Financial Institutions Base Rate: **\$235.00 + \$23.50 per **Million in assets**

**Please add \$23.50 per million in assets based on holdings within our community, not the holdings of the entire corporation.

Professional Services Base Rate: *****\$270.00**
(115% of Membership Base Rate)

Professional is defined as: a degree or certificate is required to perform work or a profession that is regulated by a state or federal agency.

Please note that all Memberships are business specific, primary and secondary businesses each pay the same rate.

PAYMENT SCHEDULE / GUIDELINES

Please note the Base Rate is \$235.00 for 12 months November 1st through October 31st. The Associate Rate is \$94.00 for 12 months November 1st through October 31st. The Professional Services Base Rate is \$270.00 for 12 months November 1st through October 31st. You are required to add additional fees to the base as listed in the additional fees area.

Please note that all member investment billing will occur on an annual or semi-annual basis. Member investment invoices will be mailed annually by October 31st with a due date of December 15th (date of maturity). Payments not received by December 30th will receive a past due letter stating his / her account is past due. Any payments not received by January 15th will receive a written notification of cancellation if one of the following options is not exercised: paying half of their membership investment by January 22nd, or paying their balance in full by January 22nd. If said member has failed to remit a payment by January 22nd, he / she shall receive a written notification of cancellation. If there is no response on or before January 22nd, it will be considered notice of membership cancellation.

If you have extenuating circumstances you are able to submit a letter of explanation with a payment plan proposal for the Chamber Board of Directors to review. The Chamber Board of Directors may decide;

- To grant an extension on the payment of the member investment based on the proposal as submitted
- To grant an extension on the payment of the member investment with a board proposed payment plan
- To reject the claim and recommend cancellation

If your membership investment is overdue no credit will be extended for additional items such as Chamber Bucks / group promotional / advertising opportunities / sponsorships / participations / attendance at events. All additional items can be paid by either cash or check until the membership investment is paid.

Chamber membership dues are non-refundable.
